## **Dates and Location:**

Market dates are listed above. The event is held at the Lied Lincoln Township Library in Wausa. There are opportunities to set up tables INSIDE or OUTSIDE depending on preference and/or weather. We start the markets on Wednesday evenings, from 5:30-7:30pm. There are two Saturdays this year, which will be from 9-11 am. Our last market is Labor Day, which is August 30<sup>th</sup> and it will be at Gladstone Park from 9-11.

### Setup:

Tables are provided for our vendors if needed, just request them at check in on the day of the event. Water and sun protection will be provided. You may come 20 minutes before the start of the event to set up.

#### **Products:**

We are strongly encouraging handmade or homemade products. Produce must be raised and harvested yourself or by someone you know.

Eggs can be sold at our market if the vendor has an egg number and keeps the eggs in a cooler.

Canned goods are allowed if there are no "chunks".

We are not allowing 3<sup>rd</sup> party vendors such as Scentsy, Tupperware, Color Street Nails, etc. unless we are expecting low attendance.

Please clearly display your prices. Stickers are available at check in if you need them. Pricing is the responsibility of the vendors.

We follow Nebraska Food Safety and Consumer Guidelines. Vendors hold all responsibility for obtaining necessary permits and following cottage food laws. Ask us for guidelines or search online.
